OFFICIAL MEETING MINUTES

IN ATTENDANCE: Chairman Ward, Commissioner Baker, Deputy Clerk Coffelt, Assessor Juszcak, Deputy Clerk Loya, Treasurer Hutchings, Ian Rosenthal, Emergency Management Coordinator Roberts, Road & Bridge Superintendent Jones.

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

AMENDMENTS TO THE AGENDA: None.

CONSTITUENT INPUT: None.

MINUTES: Commissioner Baker MOTIONED to approve the meeting minutes for Monday February 8th, 2016. Chairman Ward SECONDED; All Ayes.

DEPARTMENTAL ISSUES: Treasurer Hutchings discussed a request from Mr. Dan Cummings for help on his taxes with the Board. Chairman Ward MOTIONED to remove the remaining late fees and interest charges on the missed payments for Dan Cummings. Commissioner Baker SECONDED; All Ayes. Emergency Management Coordinator Roberts discussed with the Board the upcoming Mass Gatherings; Race to Robie, Idaho City 100 National ISDE Qualifier Enduro, and the North Fork Championship.

CONTRACTS/AGREEMENTS/GRANTS: A Change Order for the Middle Fork Bridge in Crouch was presented to the Board. Chairman Ward MOTIONED to approve the Change Order on the Crouch Bridge, key number 09521, change order number eight, contract number 7970, and a credit of \$4,800 on the load rating of the bridge evaluation. Commissioner Baker SECONDED; All Ayes. Chairman Ward MOTIONED to pay the Demand Warrant to the NORFMA c/o Sky Miller, Cardino Entrix, invoice number Ref #1530, explanation-Northwest Regional Floodplain Management Association 2016 membership dues, in the amount of \$40.00, fund number 01-21, per request of Planning & Zoning Rora Canody. Commissioner Baker SECONDED; All Ayes.

INDIGENT: Chairman Ward MOTIONED to move into executive session for indigent per I.C. 74-206(1)(d), exempt records. Commissioner Baker SECONDED. Roll call vote: Chairman Ward; Aye, Commissioner Baker; Aye. Motion passed unanimously. Coming out of executive session per I.C. 74-206(1)(d), Chairman Ward MOTIONED to sign the lien for the case 16-01-A. Commissioner Baker SECONDED; All Ayes.

GARDEN VALLEY TRANSLATOR DISTRICT LEASE AGREEMENT: Mr. Richard Pullman and Mr. Jim Conlin spoke to the Board concerning an extended lease for the tower in Garden Valley. Discussion ensued.

EBCAD UPDATE: Chairman Ward MOTIONED to recess as the Boise County Board of Commissioners and convene as the East Boise County Ambulance District Governing Board. Commissioner Baker SECONDED; All Ayes. Mr. Jerry Newland gave an update to the Board for the months of September, October and November 2015. Discussion ensued. Chairman Ward recessed as the East Boise County Ambulance District Governing Board and reconvened as the Boise County Board of Commissioners.

MISCELLANEOUS AND CORRESPONDENCE:


