

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, JUNE 25th, 2019 BOISE COUNTY COMMISSIONER'S ROOM OFFICIAL MEETING MINUTES

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

EXECUTIVE SESSION: Chairman Ward MOTIONED to move into executive session per I.C. 74-206(1)(f), pending litigation, per I.C. 74-206(1)(b), personnel, per I.C. 74-206(1)(d), exempt records, per I.C. 74-206(1)(a), to hire an employee and per I.C. 74-206(1)(i) risk management. Commissioner Stirm SECONDED. Roll call vote: Chairman Ward – Aye; Commissioner Jackson – Aye; Commissioner Stirm - Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f) pending litigation, per I.C. 74-206(1)(b) personnel, per I.C. 74-206(1)(d), exempt records, per I.C. 74-206 (1)(a), to hire an employee and per I.C. 74-206(1)(i) risk management, no action required.

MINUTES: Commissioner Jackson MOTIONED to accept the minutes for Tuesday, June 18th, 2019, as written. Commissioner Stirm SECONDED; All Ayes.

DEPARTMENTAL ISSUES: Prosecuting Attorney Strong presented documentation on an amendment to the current lease agreement for the Prosecutors Office, discussion ensued. Chairman Ward MOTIONED to approve the lease amendment between Harlan & Maxine Douglas and Boise County for the Prosecutors Office-Boise County. Commissioner Jackson SECONDED; All Ayes. Planning & Zoning Deputy Clerk Wood presented documentation on the request of a new street name, discussion ensued. Commissioner Stirm MOTIONED to add a street name to the Lowman area, north of highway twenty one (21) and highway seventeen (17) junction; name of the road will be Tower Road. Commissioner Jackson SECONDED; All Ayes. Emergency Management Coordinator Showalter updated and discussed the mobile command center. Mr. Showalter also updated on the County Auction which will be held on July 27th, 2019. Community Justice Administrator Leader discussed Scales of Justice Bass Fishing Tournament with the Board. Commissioner Stirm MOTIONED to send Amanda Leader and any juveniles through the Community Justice Office to the Scales of Justice Bass Tournament on September 15th, 2019, at CJ Strike Reservoir. Commissioner Jackson SECONDED; All Ayes. Sheriff Kaczmarek let the Board know that he will be sending out an email concerning county cell numbers to give to Verizon for notifications in an emergency.

A grant award for the Sheriffs' office was presented to the Board, discussion ensued. Chairman Ward MOTIONED to approve the grant letter from the Sheriffs' Office for Boise County to the Idaho Department of Parks & Recreation. Commissioner Jackson SECONDED; All Ayes. Resolution 2019-34 to destroy certain records of Boise County was presented to the Board for review and discussion. Commissioner Stirm MOTIONED to approve Resolution 2019-34; a Boise County resolution to destroy certain records of Boise County being it temporary to be held for two (2) years; semi-permanent to be held for five (5) years or permanent to be held for ten (10 years or more.
