**OFFICIAL MEETING MINUTES**

In attendance: Chair Wilkins, Commissioner Balding, Commissioner Anderson, Clerk Prisco and Sheriff Roeber (in a.m. session).

Chair Wilkins called the meeting to order and the Pledge of Allegiance was recited.

**COMMISSIONERS BUDGET WORKSHOPS - DEPARTMENT REQUESTS:** Sheriff Roeber presented his FY 2015 department budget requests to the Board. Chair Wilkins MOTIONED to change Rod Knopp's current salary from \$14.39 per hour to \$14.79 per hour under the Sheriff's Vessel Fund. Commissioner Balding SECONDED. All ayes; motion passed unanimously.

Prosecutor Gee presented his FY 2015 department budget request to the Board.

Valerie Delyea, Community Justice Administrator, presented her FY 2015 department budget request to the Board.

Chair Wilkins MOTIONED to move Ms. Delyea's salary up to \$37,000. Commissioner Anderson SECONDED. All ayes; motion passed unanimously.

Chair Wilkins MOTIONED to direct Ms. Delyea to park the Community Service vehicle (truck) at the building in Horseshoe Bend when the employee is not working. Commissioner Balding SECONDED. Discussion: Commissioner Anderson expressed concern over what the Judge's position on this might be. Roll call vote: Roll call vote: Chair Wilkins-aye; Commissioner Balding-aye; Commissioner Anderson-aye; motion passed unanimously.

**SOLID WASTE/NOXIOUS WEEDS DEPARTMENTS:** Superintendent Bottoms and Assistant Superintendent Rekow, presented the FY 2015 department budget requests for both the Solid Waste and Noxious Weeds departments.

Chair Wilkins MOTIONED to move the Noxious Weeds employees' salaries, to start for the Noxious Weeds Department, from May 1<sup>st</sup> through September 30<sup>th</sup>, with the remaining months (of the fiscal year) being picked up by Solid Waste. Commissioner Anderson SECONDED. Discussion: clarification of which employees and includes Mr. Bottoms, Mr. Rekow, Ms. Allred and Mr. Wilkins. All ayes; motion passed unanimously.

With unanimous consent, the Board recessed until Monday, July 28<sup>th</sup>, 2014.
