

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, AUGUST 27th, 2019 BOISE COUNTY COMMISSIONER'S ROOM **OFFICIAL MEETING MINUTES**

IN ATTENDANCE: Chairman Ward, Commissioner Jackson, Commissioner Stirm, Clerk Prisco, Deputy Clerk Coffelt, Prosecutor Strong, Sheriff Kaczmarek, Community Justice Administrator Leader, Wildland Fire Mitigation Forester Richardson, Solid Waste/Noxious Weeds Superintendent Rekow, Human Resources Director Schiffer, Planning & Zoning Administrator Caulder, Deputy Clerk Dresslar, Chief Deputy Coroner Johnson.

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

EXECUTIVE SESSION: Chairman Ward MOTIONED to move into executive session per I.C. 74-206(1)(f), pending litigation, per I.C. 74-206(1)(b), personnel, per I.C. 74-206(1)(d), exempt records, per I.C. 74-206(1)(a), to hire an employee and per I.C. 74-206(1)(i) risk management. Commissioner Jackson SECONDED. Roll call vote: Chairman Ward – Aye; Commissioner Jackson – Aye; Commissioner Stirm - Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f) pending litigation, per I.C. 74-206(1)(b) personnel, per I.C. 74-206(1)(d), exempt records, per I.C. 74-206 (1)(a), to hire an employee and per I.C. 74-206(1)(i) risk management, no action required.

CONSTITUENT INPUT: Richard Barber of Placerville is asking the Boards permission to install two portable speed bumps in the Placerville area due to the increase in traffic. The speed bumps would be removed for the snow removal months, discussion ensued. Rhonda Jalbert of the Wilderness Ranch Home Owners Association updated the Board on the replacement of the bridge accessing the Wilderness Ranch housing development (Hwy. 21) and the bridge accessing the Wilderness Ranch water treatment plant (Robie Creek Rd.). Funding has been obtained through the United States District of Agriculture Rural Development in the amount of \$2.54 million in order to replace both of the bridges. The homeowners' association dues will be raised in the amount of \$50.00 for the next thirty five (35) years.

MINUTES: Commissioner Jackson MOTIONED to accept the minutes for Tuesday, August 20th, 2019, as changed. Commissioner Stirm SECONDED; All Ayes.

DEPARTMENTAL ISSUES: Wildland Fire Mitigation Forester Richardson updated the Board on the possible purchase of a skid steer with a mulcher attachment, discussion ensued. Clerk Prisco (on behalf of Assessor Juszczak) presented a payroll change for an employee that has recently become certified as an appraiser. Chairman Ward MOTIONED to approve the payroll change in the Assessors Officer per request of Assessor Juszczak. Commissioner Jackson SECONDED; All Ayes. Chief Deputy Coroner Johnson spoke with the Board concerning the cremation fees and the process of determining which funeral homes are used. An amended indigent non-medical policy will be drafted for the cremation fees. Clerk Prisco, Community Justice Administrator Leader, and Sheriff Kaczmarek, spoke with the Board concerning installation of radios in the newly purchased county vehicles and which vendor to utilize.

Chairman Ward MOTIONED that Boise Mobile Equipment (BME) be the vendor for the radio installation for all new/replacement vehicles. Commissioner Jackson SECONDED; All Ayes.
