A BOISE COUNTY RESOLUTION TO TRANSFER OWNERSHIP OF SURPLUS PERSONAL PROPERTY TO POLITICAL SUBDIVISIONS

WHEREAS, the Boise County Board of County Commissioners had declared that certain personal property of Boise County, identified by the Boise County Technology Committee, be deemed as surplus; and

WHEREAS, I.C. 31-808(9) allows a Board of County Commissioners to transfer or exchange, real or personal property, with another political subdivision; and


WHEREAS, the Boise County Board of Commissioners agreed that a portion of the surplus could be transferred to the East Boise County Ambulance District, a political subdivision, for their official use; and

WHEREAS, the Boise County Board of Commissioners agreed that a portion of the surplus could be transferred to the Horseshoe Bend and Garden Valley School Districts, both political subdivisions, for their official use.

NOW THEREFORE BE IT RESOLVED, that the Boise County Board of Commissioners has approved the transfer of the personal property as identified on the attached list.

APPROVED and ADOPTED in open session this 20th day of December, 2013.


