A BOISE COUNTY RESOLUTION REPEALING RESOLUTION 2006-27 BOISE COUNTY COMPREHENSIVE PLAN AND LAND USE MAP, AS AMENDED, AND ADOPTING A NEW BOISE COUNTY COMPREHENSIVE PLAN AND LAND USE MAP.

WHEREAS, the Local Land Use Planning Act as enacted by the Idaho Legislature, I.C. 67-6501 et. seq., requires counties and municipalities to conduct a comprehensive planning process designed to prepare, implement and review, update a comprehensive plan and sets out the required components of such plans; and

WHEREAS, the Boise County Comprehensive Plan and Land Use Map was last fully reviewed and updated in 2006; and

WHEREAS, a citizen committee chaired by members of the Boise County Planning and Zoning Commission, starting in 2009, undertook a public review of the current Boise County Comprehensive Plan and subsequently determined that some amendments to the plan were warranted; and

WHEREAS, the Boise County Planning and Zoning Commission, pursuant to Idaho Code 67-6508, held a duly noticed public hearing on the plan on April 15, 2010 and recommended approval of the amendments to the Board of Boise County Commissioners; and

WHEREAS, the Board of Boise County Commissioners held three (3) duly noticed public hearings on the plan on March 20, 2010 at the Garden Valley Senior Center, on March 22, 2010 at the Horseshoe Bend Ladies Club Hall and on April 5, 2010 at the Idaho City Commissioner Chambers; and

WHEREAS, the Board of Boise County Commissioners deliberated on April 19, 2010, May 3, 2010 and May 24, 2010 on the amendments to the plan, made some additional non-material amendments to the plan and approved, by motion, to accept and approve the revised Boise County Comprehensive Plan 2010 update on May 24, 2010; and

WHEREAS, pursuant to Idaho Code 67-6509(d) the Boise County Planning and Zoning Commission has not recommended and the Board of County Commissioners has not considered an amendment to the Boise County Comprehensive Plan or Land Use Map for more than six months.

NOW THEREFORE BE IT RESOLVED, by the Boise County Board of Commissioners, State of Idaho, that the Boise County Comprehensive Plan and Land Use Map, as adopted by Resolution 2006-27, be repealed and that the Boise County Comprehensive Plan 2010 update, dated May 24, 2010 and the Boise County Current Land Use Map, dated 2009, be adopted.
