### A BOISE COUNTY RESOLUTION CLARIFYING FEES FOR BOISE COUNTY SOLID WASTE

**WHEREAS**, the Boise County Board of Commissioners has the authority to set fees in relationship to transportation of, and disposal of, Solid Waste, pursuant to Idaho Code 31-4404; and

**WHEREAS**, the Boise County Board of Commissioners has reviewed Resolution #2014-29, in conjunction with the current costs of operations.

**NOW THEREFORE BE IT RESOLVED**, that the Boise County Board of Commissioners rescinds Resolution #2014-29; and

**BE IT FURTHER RESOLVED** that the Boise County Board of Commissioners adopts the following fee schedule of Solid Waste fees, by type of property parcel:
