

REGULAR MEETING OF THE BOISE COUNTY PLANNING & ZONING COMMISSION

September 20, 2018 Garden Valley School Multipurpose Room 1052 Banks Lowman Road Garden Valley, ID 83622

Present: Vice Chair Edith Williams, Commissioner Tim Fritzley and Commissioner Pam Sonnen were present.

Staff Present: P&Z Administrator Bret Caulder and P&Z Admin Assistant Malynda Turner-Danes, P&Z Admin Assistant Brenda Wood-Hanson and P&Z Attorney Steven Meade.

Roll Call: Vice Chair Williams requested the roll call; all three (3) P&Z Commission members were present.

Establish a Quorum and call the meeting to order: Vice Chair Williams declared a quorum was present and called the regular meeting to order at 6:30 p.m.

Review Agenda, any amendments: No amendments were made. Commissioner Fritzley made a motion to approve the agenda; seconded by Commissioner Sonnen. All Ayes. Motion carried.

Approve Minutes: Commissioner Sonnen made a motion to approve the 8/16/18 minutes as presented; seconded by Commissioner Fritzley. All Ayes. Motion carried.

Public Hearing: Conditional Use Permit #2014-003AMD Creekside RV Park:

Vice Chair Williams opened the public hearing at 6:34 p.m. Vice Chair Williams called upon applicant, Gayle Strack for Creekside RV Park, for their presentation and answered questions from the Commission regarding flood zone, central district health and parking.

No one gave testimony opposed or neutral to the application and four (4) people gave testimony in favor of the application.

The Applicant gave no rebuttal testimony.

Vice Chair Williams requested the staff's overview for the application from the Planning and Zoning Administrator Bret Caulder. Administrator Caulder proceeded with the visual PowerPoint on the application.

Deliberation ensued. The Commission then read each Finding and made an addition. The Commission proposed to strike original site specific condition #2 but wants legal to research. Legal recommends to include wording "comments and/or requests" in the proposed site specific condition #3. Commissioner Sonnen made a motion to approve CUP #2014-003AMD with the stated changes; Commissioner Fritzley seconded.

Administrator Caulder also informed the Commission that the ULO Amendments went to the Board for public hearing and were approved.
