Chairman Ward MOTIONED on parcel number RP09N04E108570 to amend the valuation of the Assessors' Office in category thirty one (31) from \$197,051 to \$132,739 to include category thirty two (32) amended from \$8,862 to \$6,189. Commissioner Stirm SECONDED; All Ayes. Chairman Ward MOTIONED on parcel number RP09N04E108580 to amend the valuation from the Assessors' Office from category thirty two (32) in the amount of \$84,821 to \$95,024. Commissioner Stirm SECONDED; All Ayes.


