Precinct	<p>Shall the Board of Trustees of Basin School District 72 of Boise County, Idaho, be authorized and empowered to levy a supplemental levy, as permitted by law under Section 33-802(3), Idaho Code, in the amount of Seven Hundred Ninety Two Thousand Dollars 00/100 (\$792,000), \$792,000, per year for a period of two (2) years, for a total of One Million Five Hundred Eighty Four Thousand Dollars and 00/100 (\$1,584,000), for the purpose of paying the above-identified lawful expenses to maintain and operate the schools of the District for the fiscal years beginning July 1, 2024 and ending June 30, 2026?</p> <p>The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$73.11 per \$100,000.00 of taxable assessed value, per year, based on current conditions.</p> <p>The proposed levy replaces an existing levy that will expire on June 30, 2024 and that currently costs \$45.70 per \$100,000 of taxable assessed value. If the proposed levy is approved, the tax per \$100,000 of taxable assessed value is either: (i) not expected to change or (ii) is expected to increase or decrease the tax by \$27.41 per \$100,000 of taxable assessed value.</p>
