GENERAL SUMMARY

Advocate for community wildfire preparedness and can work independently with minimal oversight. Promotes, manages and directs fuels reduction and community wildfire preparedness while reducing the risk of wildfire in the wildland urban interface, and performs related work as required.

- Identify wildfire risk and develop solutions for mitigating the risk
- Design and implement fuels modification projects throughout Boise County to reduce the danger of wildfire impacts to homes and developments
- Ability to develop and administer contracts, work with contractors
- Perform Wildland Urban Interface (WUI) inspections as requested
- Prepare requests for grants for federal or state funded programs/projects for Hazardous Fuel Treatments.
- Administers grant awards and submits required reporting
- Represents the County in groups and committees which promote active management of state and federal forest lands throughout Boise County in the absence of the Wildfire Mitigation Manager
- Compile information and write community wildfire preparedness plan (CWPP)
- Promote national wildfire preparedness programs
- Organizes and participates in state and regional courses, workshops and conferences to improve the ability of Boise County to survive catastrophic fire.
- Community engagement/education.
- Performs all duties with due regard to personal safety of employees and public; insures less skilled personnel comply with applicable safety and occupational health standards. Maintains good working relationships and communication with employees and the public. Establishes a public image that reflects favorable on county employees in use of county equipment, work ethics and public service attitudes.
