

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, DECEMBER 11TH, 2018 BOISE COUNTY COMMISSIONER'S ROOM **OFFICIAL MEETING MINUTES**

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

Commissioner Jackson SECONDED. Roll call vote: Chairman Ward – Aye; Commissioner Jackson – Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f) pending litigation, per I.C. 74-206(1)(b) personnel, per I.C. 74-206(1)(d), exempt records, and per I.C. 74-206 (1)(a), to hire an employee and per I.C. 74-206(1)(i), risk management, no action required.

MINUTES: Commissioner Jackson MOTIONED to approve the minutes for December 4th, 2018 as written and presented. Chairman Ward SECONDED; All Ayes.

DEPARTMENTAL ISSUES: <u>Clerk Prisco</u> updated the Board on the fire alarm system that will be installed in the Miners' Exchange Building now that it has been approved by the fire marshal. <u>Emergency Management Coordinator Showalter</u> presented a letter for site permission for emergency management to the Board from a doctoral student at Capella University as a requirement for her studies, discussion ensued. This request has been denied by the Board. <u>Wildland Fire Mitigation Forester Richardson</u> discussed with the Board Bureau of Land Management Grant funds.

BOISE COUNTY POLICIES: The Road & Bridge snow removal and sanding policy was reviewed and discussed. Five (5) other surrounding county policies were used for comparison in the discussion.

CONTRACTS/AGREEMENTS/GRANTS/RESOLUTIONS: An agreement for the Noxious Weeds Department in the Boise Basin area was presented to the Board for review and discussion. These agreements have been tabled until December 18th, 2018. An agreement for the Noxious Weeds Department in the Upper Payette area was presented to the Board for review and discussion. An agreement to provide equipment in the event of an emergency in Boise County was presented to the Board by Mr. Showalter for review and discussion. A final discussion concerning the Mass Gathering Ordinance and its amendments ensued before the public hearing which is to take place next Tuesday, December 18th, 2018 at 2:00pm in the Miners' Exchange Building-Commissioner Room.

An amendment was made to the EBCAD Assistant Director/Logistics Officer Job Description and was presented and discussed with the Board. Chairman Ward MOTIONED to approve the EBCAD Assistant Director/Logistics Officer Job Description as presented by Director Potts. Commissioner Jackson SECONDED; All Ayes. A payroll change was presented to the Board for the new EBCAD Director for review and approval. Chairman Ward MOTIONED to approve the payroll change for EBCAD in the Directors position as presented. Commissioner Jackson SECONDED; All Ayes. Application review for the

EBCAD Assistant Director/Logistics Officer ensued. Director Potts discussed briefly the Drug and Alcohol Policy for EBCAD which will be added to a later agenda. Chairman Ward recessed as the EBCAD Governing Board and reconvened as the BOCC.
