

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, MARCH 27th, 2018 BOISE COUNTY COMMISSIONER'S ROOM **OFFICIAL MEETING MINUTES**

Commissioner Jackson called the meeting to order and the pledge of allegiance was recited.

Mr. Frank Gladics informed the Board of an update on the Title I, II and III funds which will be extended for another two (2) years, discussion ensued. The PILT funds have been fully funded as well. A certificate of appreciation was presented to Ms. Rora Canody by the Board for her thirty (30) years of service to Boise County.

Resolution 2018-20 a budget adjustment for the Elections Department was presented to the Board, discussion ensued.
