

## BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, AUGUST 7<sup>th</sup>, 2018 BOISE COUNTY COMMISSIONER'S ROOM **OFFICIAL MEETING MINUTES**

Chairman Ward called the meeting to order and the pledge of allegiance was recited.

Commissioner Jackson SECONDED. Roll call vote: Chairman Ward; Aye; Commissioner Jackson; Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f) pending litigation, per I.C. 74-206(1)(b) personnel, per I.C. 74-206(1)(d), exempt records, and per I.C. 74-206 (1)(a), to hire an employee and per I.C. 74-206(1)(i), risk management, Chairman Ward MOTIONED to authorize Daniel Glynn to proceed with pending back pay litigation, Commissioner Jackson SECONDED; further discussion ensued. Road and Bridge Superintendent Jones discussed parking equipment on forest land in Grimes Creek area. Mr. Jones presented documentation on reimbursement extension with Western Federal Lands Highway Division to the board. Chairman Ward MOTIONED to approve the reimbursement extension with the Idaho Transportation Department to include Western Federal Lands Highway Division as per request of the road and bridge department of Boise County, Commissioner Jackson SECONDED. All Ayes. Mr. Jones presented documentation on Chip Sealing Projects for Boise County, discussion ensued. Commissioner Jackson MOTIONED to spend \$217,000 on various (chip/seal) road projects in the County, Chairman Ward SECONDED; further discussion ensued. All Ayes. Community Justice Administrator Leader presented Ductless System A1, Boise Western Heating & Air and Diamond bids, along with a Bid from Mr. Electric to the board, discussion ensued. Chairman Ward

MOTIONED to approve the bid from Mr. Electric and Boise Western Heating and Air for 24,000 BTU Unit for Community Justice. Commissioner Jackson SECONDED; further discussion. All Ayes.

Certificate of residency was presented to the board, Chairman Ward MOTIONED to approve Certificate of Residency #123. Commissioner Jackson SECONDED; All Ayes. Chairman Ward discussed a letter to Frontier, tabled for a later date.
