

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, OCTOBER 30th, 2018 BOISE COUNTY COMMISSIONERS' ROOM **OFFICIAL MEETING MINUTES**

DEPARTMENTAL ISSUES: Emergency Management Coordinator Showalter discussed with the Board the possible scheduling of a phone/internet service media public meeting. Mr. Showalter introduced an idea to the Board of employees of Boise County being certified to drive the Idaho City Ambulance, discussion ensued. Sheriff Kaczmarek presented documentation to the Board concerning vehicle leases, discussion ensued. Road & Bridge Superintendent Jones presented documentation for a payroll change and a payroll addition to the Board, discussion ensued. The payroll change has been tabled. Commissioner Baker MOTIONED to approve the hiring of Aric Stone in the amount of \$15.69 per hour, full time position for the Road & Bridge Department. Commissioner Jackson SECONDED; All Ayes. Clerk Prisco gave an update to the Board on the upcoming election next Tuesday along with the new Express Vote machine the county has purchased, as well as how the voters are accepting it.

Commissioner Jackson SECONDED; All Ayes. Chairman Ward MOTIONED in the matter of case number 19-10-E to sign the lien(s) in a thirty one (31) day emergent case. Commissioner Jackson SECONDED; All Ayes.

DEPARTMENT HEAD/ELECTED OFFICIALS MEETING: A brief discussion with Michael Timmerman from M2 Automation concerning a fire alarm system to be installed in the County Buildings. A discussion ensued concerning a fuel card program through WEX Inc. A discussion ensued concerning the Mass Gathering Ordinance which is in the works of being amended. Chairman Ward MOTIONED to move into executive session per I.C. 74-206(1)(f), pending litigation, per I.C. 74-206(1)(b), personnel, per I.C. 74-206(1)(a), to hire an employee, and per I.C. 74-206(1)(i), risk management. Commissioner Jackson SECONDED. Roll call vote: Chairman Ward – Aye; Commissioner Jackson – Aye; Commissioner Baker-Aye. Motion passed unanimously. Chairman Ward brought the meeting out of executive session per I.C 74-206(1)(f)

pending litigation, per I.C. 74-206(1)(b) personnel, per I.C. 74-206 (1)(a), to hire an employee, and per I.C. 74-206(1)(i), risk management, no action required. Discussion ensued concerning posting of the EBCAD Director position on the website, in the Idaho World and possibly Indeed.com. Chairman Ward recessed as the EBCAD governing board and reconvened as the BOCC.
