## A BOISE COUNTY RESOLUTION ADJUSTING THE FY2010 BOISE COUNTY SHERIFF BUDGET AND JUSTICE FUND

WHEREAS, the FY2010 Budget for Boise County Sheriff's Department Budget was adopted by the Board of County Commissioners based upon anticipated revenue; and

**WHEREAS,** the Boise County Sheriff's Office will receive unanticipated revenues from the Idaho Transportation Department for traffic enforcement work; and

**WHEREAS**, the Boise County Sheriff's Office will receive unanticipated revenues from the Idaho Sheriff's Association for drug eradication;

**WHEREAS**, the Boise County Sheriff's Office will receive unanticipated revenues from the U.S. Corps of Engineers for campground and route patrols; and

WHEREAS, Idaho Code Section 31-1605 allows the Board of County Commissioners to adjust the Budget; and

**WHEREAS,** the annual budget procedure has been complied with in making the said adjustment and the budget adjustment shall not result in increased property taxes.

**NOW THEREFORE BE IT RESOLVED,** that the FY2010 Budget for the Boise County Justice Fund be increased in the amount of <u>\$ 41,555.49</u> as follows:
