PUBLIC HEARING: TREETOP MOUNTAIN ESTATES PRELIMINARY FULL

APPLICATION: Administrator Patti Burke presented maps of the estates and gave general information on the properties involved. Applicant, Jason Crawforth, was present and spoke concerning the estates. Adjacent landowners spoke in favor of the application and one landowner asked Mr. Crawforth to address a road issue. Administrator Patti Burke read the Findings, Facts and Conclusions into the record. Commissioner Terry C Day made a MOTION to approve the preliminary full application. PLANNING & ZONING: Administrator Patti Burke presented the Treetop Mountain Road Development Agreement with the change that payment would be due when the final plat is recorded or within 30 days of closing of the first lot sale in the subdivision. Commissioner Linda W Zimmer made a MOTION to accept the Capital Contribution Agreement. Commissioner Terry C Day SECONDED. All ayes, motion carried.

Administrative Assistant Rora Canody presented the Sunrise Meadows #4 Road Development Agreement. Chairman Fred H Lawson made a MOTION to sign the Capital Contribution Agreement. Commissioner Terry C Day SECONDED. All ayes, motion carried.

Administrator Burke stated that South Fork Landing had submitted paperwork for Phase 2. Administrator Burke presented the office remodel layout to the Board. Commissioner Terry C Day made a MOTION to move forward with the remodel. Chairman Fred H Lawson SECONDED. All ayes, motion carried.

EMERGENCY MANAGEMENT: Gordon Ravenscroft presented the 2007 State Homeland Security Grant Program award document for Board approval. Chairman Fred H Lawson made a MOTION to approve the grant. Commissioner Linda W Zimmer SECONDED. All ayes, motion carried.

WILDERNESS RANCH FIRE PROTECTION DISTRICT: John McCarthy spoke to the Board concerning a grant from Idaho Department of Health and Welfare Emergency Services Bureau and asked for the Board's support. Chairman Fred H Lawson made a MOTION to sign the approval for the grant. Commissioner Linda W Zimmer SECONDED. All ayes, motion carried.

EBCA: The Flying J fuel credit card request was discussed at the EBCA meeting. Commissioner Terry C Day made a MOTION to approve a second credit card for the Placerville Ambulance. Commissioner Linda W Zimmer SECONDED. All ayes, motion carried.

ROAD DEPT: The Crosstimber Ranch/Alder Creek Paving Trust was discussed. Clerk Swearingen stated that after researching the issue, a trust had not been set up but that she would investigate further. Supervisor Bill Jones presented demand warrants for Holladay Engineering (\$2833.13) and J-U-B Engineering (\$4337.48). Chairman Fred H Lawson made a MOTION to pay the demands for Holladay Engineering and J-U-B Engineering. Commissioner Linda W Zimmer SECONDED. All ayes, motion carried.

PA ISSUES : Deputy Prosecutor Tim McNeese gave an update on the status of the Placerville Ambulance Easement issue. Future prosecutor Ron Twiliger introduced himself to the Board.
Commissioner Linda W Zimmer asked about leasing the old library building to Isaiah's Ranch.
