RESOLUTION #2012-10

A RESOLUTION TO CORRECT THE ERRONEOUS LEVIES SET FOR BOISE COUNTY, THE EAST BOISE AMBULANCE DISTRICT, THE BOISE BASIN LIBRARY DISTRICT AND THE BOISE SCHOOL DISTRICT NO. 1

Whereas, The Board of Commissioners of Boise County have the authority and duty under Idaho Code 63-803 to make a tax levy as a percent of taxable value of all property in each taxing district, which when applied to the tax rolls, will meet the budget requirements certified by such taxing districts; and

Whereas, The State Tax Commission discovered an error on November 16th, 2011 in the 2011 operating property value that it listed for Boise County, the East Boise Ambulance District, the Boise Basin Library District and the Boise School District No. 1, and reported the error to the Boise County Board of Commissioners on November 21st, 2011, thereby meeting the deadline of the fourth Monday of November, pursuant to Idaho Code 63-810(1)(a) to discover such errors; and

Whereas, the erroneous value was included in the value used to set the property tax levies for the indicated taxing districts, thereby producing levy rates that are too low to meet the budget requirements certified by these taxing districts; and

Whereas, The Board reviewed the circumstance of this error during a public hearing on December 19th, 2011 and the need to correct the tax levies for the indicated taxing districts has been satisfactorily demonstrated to the Board of Commissioners;

It is Hereby Resolved and Ordered:

1. The 2011 tax levy for Boise County is corrected from 0.00499779 to 0.005126318.
2. The 2011 tax levy for the Boise School District No. 1 is corrected from 0.005495008 to 0.005501947.
3. The 2011 tax levy for the East Boise Ambulance District is corrected from 0.000330048 to 0.000350097.
4. The 2011 tax levy for the Boise Basin Library District is corrected from 0.000859173 to 0.000909481.
5. The 2011 taxable value for Boise County is corrected from \$680,956,066 to \$663,881,407.


6. The 2011 taxable value for the Boise School District No. 1 is corrected from \$13,540,733,959 to \$13,523,659,300.
7. The 2011 taxable value for the East Boise Ambulance District is corrected from \$298,165,611 to \$281,090,952.
8. The 2011 taxable value for the Boise Basin Library District is corrected from \$308,681,638 to \$291,606,979.
9. That this resolution shall have effect immediately upon its passage.

Passed, at a public hearing of the Boise County Board of Commissioners in the County of Boise, State of Idaho held on the 19th day of December, 2011, upon which roll call vote was duly taken and said resolution duly passed by a vote of unanimous.


