A BOISE COUNTY RESOLUTION ADOPTING THE EAST BOISE COUNTY AMBULANCE DISTRICT BUDGET FOR FISCAL YEAR 2013

WHEREAS, the Boise County Board of Commissioners, pursuant to Idaho Code §31-1605, published the date, time, and place for the public hearing on the East Boise County Ambulance District FY 2013 Budget; and

WHEREAS, the Boise County Board of Commissioners held the public hearing on the East Boise County Ambulance District FY 2013 Tentative Budget in the Commissioner Chambers located within the Miner's Exchange Building, 420 Main Street, Idaho City, Idaho on Monday, August 27th, 2012; and

WHEREAS, the Boise County Board of Commissioners did make certain changes to the proposed East Boise County Ambulance District FY 2013 Tentative Budget;

NOW, THEREFORE BE IT RESOLVED, that upon conclusion of said hearing, the Boise County Board of Commissioners determined and fixed the amount of the East Boise County Ambulance FY 2013 Budget in the amount of \$189,023; which is in the same amount of the published East Boise County Ambulance District FY 2013 Tentative Budget.
