### A BOISE COUNTY RESOLUTION TO TRANSFER ITEMS PURCHASED UNDER THE CENTRAL DISTRICT HEALTH DEPARTMENT, ASPR ALLOTMENT XI REIMBURSEMENT, TO AMBULANCE UNITS IN BOISE COUNTY AND SHERIFF'S DEPARTMENT VEHICLES

**WHEREAS**, it was advantageous to purchase volume quantities of communication and ambulance equipment for emergency service units within Boise County; and,


**WHEREAS**, Central District Health Department preferred to centralize communication, payment and administrative functions, where possible, the funding for emergency service units in Boise County was managed through East Boise County Ambulance District and Boise County government; and,

**WHEREAS**, I.C. 31-808(9) allows a Board of County Commissioners to transfer or exchange, real or personal property, with another political subdivision;

**NOW THEREFORE BE IT RESOLVED**, that the Boise County Board of Commissioners has approved the transfer of radio equipment, per the attached list, in the amount of \$2,571.50 to Horseshoe Bend Ambulance (a component of the City of Horseshoe Bend, a political subdivision), and \$20,572.00 to the Boise County Justice Fund, Sheriff's Department.

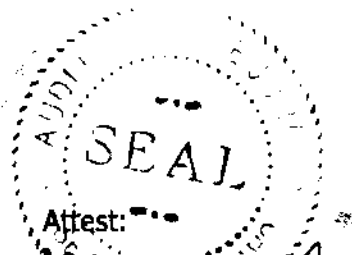


