A BOISE COUNTY RESOLUTION ADJUSTING THE BOISE COUNTY GV SNOWMOBILE FUND, FY 2016 BUDGET

WHEREAS, the FY 2016 budget, for the Boise County Garden Valley Snowmobile Fund was adopted by the Board of County Commissioners on August 25th, 2015; and

WHEREAS, Idaho Code Section 31-1608, EXPENDITURES TO MEET EMERGENCY, allows the Board of County Commissioners to adjust the budget, as adopted, to restore public property to a condition of usefulness; and

WHEREAS, I.C. 31-1608 allows the board of county commissioners to adopt, by an unanimous vote of the commissioners, a resolution stating the facts constituting the emergency and entering the same upon their minutes, and make the expenditures necessary to investigate, provide for and meet such an emergency; and

WHEREAS, the Garden Valley Snowmobile Fund has incurred unanticipated expenses, associated with the breakdown of the T2000 Tucker Snow Groomer, and; which is property of the State of Idaho, and;

WHEREAS, the Idaho State Department of Parks & Recreation Snow Groomer Program requires counties to finance repairs to said snow groomers, and; the funds are acquired through snowmobile registration fee revenues, and; which accumulate in the Garden Valley Snowmobile Fund balance, and;

WHEREAS, the Idaho State Department of Parks & Recreation reimburses fifty percent of unanticipated expenses related to State owned snow groomers, and;

WHEREAS, the annual budget has been complied with, in making the said adjustments, and the budget adjustments shall not result in increased property taxes;

NOW THEREFORE BE IT RESOLVED, that the FY 2016 budget for the Boise County Garden Valley Snowmobile Fund be adjusted as follows:
