RESOLUTION #2016-42

A BOISE COUNTY RESOLUTION DOCUMENTING USDA FUNDS FOR THE SHERIFFS OFFICE

WHEREAS, the Board of County Commissioners ("Board") is responsible for fixing the compensation of all county officers and employees, and to provide for the payment of the same pursuant to Section 31-816, Idaho Code; and

WHEREAS, the County has entered into an agreement with the United States Department of Agriculture ("USDA"), which is attached to this resolution and incorporated by reference, in which the USDA will reimburse the County for hours billed by the Sheriff's employees for special enforcement activities; and

WHEREAS, Sheriff Kaczmarek worked 33 hours for the pay period ending July 23, 2016; 139.5 hours for the pay period ending August 6, 2016; and 68.5 hours for the pay period ending August 20, 2016; all to aid USDA with the Pioneer Fire as documented by time sheets attached to this resolution and incorporated by reference; and

WHEREAS, the USDA will reimburse the County for special enforcement activities at \$60 per hour; and

WHEREAS, the Board desires to recognize the work that Sheriff Kaczmarek has put into serving the County, even though the Sheriff is an elected official and is therefore ineligible for overtime pay; and

WHEREAS, pursuant to Section 31-828, Idaho Code, the Board has the authority to do and perform all other acts necessary to the full discharge of the duties of the chief executive authority of the county government; therefore be it

RESOLVED that the County apply for payment from the USDA for a total of 241 hours of Sheriff Kaczmarek's time at the rate of \$60 per hour for a total payment of \$14,460.00; and

RESOLVED that the County provide a stipend to the Sheriff from the funds from the USDA in the amount equal to his hourly rate plus benefits for a total of \$6,742.15; and

RESOLVED that the remainder of the funds from the USDA, \$7,717.85, be put in the Justice Fund for the Sheriff's Office.

RESOLVED that Resolution #2016-42, known as USDA Funds for the Sheriff's Office, be effective as of September 6, 2016.


