OFFICIAL MEETING MINUTES

Chairman Twilegar called the meeting to order and the pledge of allegiance was recited.

EXECUTIVE SESSION: None at this time.

CONSTITUENT INPUT: None.

MINUTES: Chairman Twilegar MOTIONED to accept the official meeting minutes from Tuesday, March 1st, 2022 as written. Commissioner Stirm SECONDED; All Ayes. Chairman Twilegar MOTIONED to accept the official special meeting minutes from Thursday, March 3rd, 2022 (to realign the Board of Commissioners) as written. Commissioner Stirm SECONDED; All Ayes. Chairman Twilegar MOTIONED to accept the official special meeting minutes from Thursday, March 3rd, 2022 (Robie Creek Cell Tower Public Hearing) as written. Commissioner Stirm SECONDED; All Ayes.

DEPARTMENTAL ISSUES: The Board of Commissioners discussed a job description for a grant writer position. Planning & Zoning Administrator Gross presented documents to the Board for review, discussion ensued concerning the possible purchase of a generator for the Planning & Zoning building. The possible addition of the Community Justice Building, Courthouse and the Prosecuting Attorneys' Office discussion ensued. IT Director McCracken updated the Board on the attack of the County system that has been taking place this week and how he has been handling the situation. Treasurer Turner updated the Board on a security measure that is paid for through the Treasurers' office.

A boating safety grant agreement renewal was presented to the Board for review, discussion ensued. Chairman Twilegar MOTIONED to approve the agreement between the Idaho Department of Parks and Recreation and Boise County for 2022. Commissioner Stirm SECONDED; All Ayes. Resolution 2022-13 to amend the Revaluation Fund salary budget was presented to the Board for review and discussion. Commissioner Stirm MOTIONED to adopt Resolution 2022-13: a Boise County resolution amending the Boise County Revaluation Fund, FY 2022 budget. Chairman Twilegar SECONDED; All Ayes.

CORRESPONDENCE: The bills/claims were presented to the Board for review and approval. Chairman Twilegar MOTIONED to pay the bills/claims in the amount of \$153,606.34 dated March 4th, 2022. Commissioner Stirm SECONDED; All Ayes.


