OFFICIAL MEETING MINUTES

Chairman Twilegar called the meeting to order and the pledge of allegiance was recited.

CONSTITUENT INPUT: None at this time.

MINUTES: Chairman Twilegar MOTIONED to approve the official meeting minutes for October 4th, 2022, as written. Commissioner Tucker SECONDED; All Ayes.

DEPARTMENTAL ISSUES:

Clerk Prisco and Prosecuting Attorney Strong spoke to the Board concerning an invoice that is being disputed from Computer Arts Inc.

Treasurer Turner presented a tax cancelation request to correct billing on a parcel that belongs to the federal government, to the Board for review, discussion ensued. Chairman Twilegar MOTIONED to approve the request for tax cancelation for the United States of America in the amount of \$31.72. Commissioner Tucker SECONDED; All Ayes.

Roll call vote: Chairman Twilegar – Aye; Commissioner Tucker – Aye; Commissioner Stirm - Aye. Motion passed unanimously. Chairman Twilegar brought the meeting out of executive session per I.C. 74-206(1)(b), personnel, no action required. Chairman Twilegar MOTIONED to move into executive session per I.C. 74-206(1)(f), pending litigation, to discuss a pending litigation item. Commissioner Tucker SECONDED. Roll call vote: Chairman Twilegar – Aye; Commissioner Tucker – Aye; Commissioner Stirm - Aye. Motion passed unanimously. Chairman Twilegar brought the meeting out of executive session per I.C. 74-206(1)(f), pending litigation, no action required.

RS2477 ROADS: PROCESS DISCUSSION: Prosecutor Strong went over what consists of a RS2477 road and how a RS2477 road could be created in the State of Idaho; discussion ensued among the Board, and Prosecutor Strong.

PUBLIC HEARING: DANIEL YOUNGWORTH PARTIAL PLAT AMENDMENT: Chairman Twilegar opened the public hearing. Planning & Zoning administrator Gross went over the application with the Board, discussion ensued. Chairman Twilegar opened up the public testimony portion of the hearing. Mr. Youngworth spoke to the Board concerning his application. Mr. Fred Ramisch spoke of his concerns on this matter. Chairman Twilegar closed the public testimony portion of the hearing. Chairman Twilegar MOTIONED to approve the partial plat amendment for parcel number RP001670050210 and RP06N05E136652, to include

the conditions as written. Commissioner Tucker SECONDED; All Ayes. Chairman Twilegar closed the public hearing.

PUBLIC HEARING: OLD MILLS ACRES MINOR SUBDIVISION FINAL PLAT APPROVAL: Chairman Twilegar opened the public hearing. Planning & Zoning administrator Gross went over the application with the Board, discussion ensued. Chairman Twilegar opened up the public testimony portion of the hearing. Mr. Armstrong was present but no public testimony was given. Chairman Twilegar closed the public testimony portion of the hearing. Chairman Twilegar MOTIONED to approve the subdivision minor plat for Mr. Armstrong on the Old Mills Acres Subdivision, to include the road change and the conditions as written. Commissioner Tucker SECONDED; All Ayes. Chairman Twilegar closed the public hearing.
