## **RESOLUTION #2018-19**

## A BOISE COUNTY RESOLUTION SETTING SOLID WASTE FEES FOR EXTRAORDINARY ITEMS AT THE HORSESHOE BEND TRANSFER STATION

**WHEREAS,** the Boise County Board of Commissioners has the authority to set fees in relationship to transportation and disposal of Solid Waste pursuant to Idaho Code 31-4404; and

**WHEREAS,** the Boise County Board of Commissioners has reviewed Resolution #2017-14 and current costs of operations and found need for revision due to the addition of a weight scale at the Horseshoe Bend Transfer Station; and

**WHEREAS,** notice of public hearing was published in the Idaho World on 28<sup>th</sup> of February and 7<sup>th</sup> of March, 2018; and

**WHEREAS,** a public hearing was held on this matter on 14<sup>th</sup> of March 2018 where the Boise County Board of Commissioners considered the setting of fees that are reasonably related to costs pursuant to Idaho Code 31-870.

**NOW, THEREFORE, BE IT RESOLVED** that the Boise County Board of Commissioners affirms the fees set by Resolution #2017-14, with the exception of Construction and Demolition Debris at the Horseshoe Bend Transfer Station (in the event of scale failure the fees set by Resolution #2017-14 shall apply); and

**FURTHER BE IT RESOLVED** that the Boise County Board of Commissioners adopts the following fee schedule and limitations for disposal of extraordinary items by weight at the Horseshoe Bend Transfer Station:

ITEM FEES

CONSTRUCTION and DEMOLITION (C&D) MATERIALS:

C & D WASTE \$70 / ton

C & D waste shall be less than 6 feet in length

C & D waste shall be separated from household waste

C & D waste shall be separated from appliances, metal and tires

CONCRETE shall have no rebar and be less than 16 inches any dimension
