**A RESOLUTION ESTABLISHING A SCHEDULE OF FEES
FOR BUILDING PERMITS IN ACCORDANCE WITH
BOISE COUNTY BUILDING PERMIT
INTERIM ORDINANCE #1-2000, SECTION 6
AND RESCINDING RESOLUTION #99-21**

WHEREAS, Boise County has Interim Ordinance #1-2000 currently in effect, and

WHEREAS, Interim Ordinance #1-2000 requires the issuing of a building permit and may require inspections by a certified building official, and


WHEREAS, the cost of such services should be funded through the use of building permit fees, and

WHEREAS, the ordinance requires that such fees be set by resolution,



APPROVED AND ADOPTED by the Boise County Board of Commissioners in open session on the 22nd day of February 1999.





Other Inspections and Fees:

1. Inspections outside of normal business hours\$23.50 per hour
2. Reinspection fees\$23.50 per hour
3. Inspections for which no fee is specifically indicated (min 1 hour).....\$23.50 per hour
4. Plan check fee included in the Building Permit Fee.
5. Additional plan review required by changes, additions or revisions.....\$23.50 per hour
6. For use of outside consultants for plan checking and inspections, or both..... Actual costs

Other Building Permit Fees

- Mobile/Manufactured Homes (inspection for tie-down or secured on foundation)..... \$50.00
- Outbuildings (exempted) 25.00
- (if outbuildings are built to code and buildier requests inspections then fee will be set according to value fee schedule as described in table above)
- Residences choosing exemption from Building Codes(same as for mobile/manufactured home)
- Moving of Building (same as for manufactured/mobile home)

TOTAL VALUATION FOR THE PURPOSE OF PERMIT AND PLAN-CHECKING FEES SHALL BE BASED ON THE LATEST PUBLISHED AVERAGE COST PER SQUARE FOOT, EXCLUDING REGIONAL MODIFIERS AS PUBLISHED BY THE ICBO, OR THE ACTUAL ACCEPTED BID PRICE BY A CONTRACTOR, PROVIDED DOCUMENTARY EVIDENCE OF SUCH ACCEPTED BID PRICE IS SUBMITTED WITH THE BUILDING PERMIT APPLICATION.
