## RESOLUTION #2002-30

### **A BOISE COUNTY RESOLUTION COMMEMORATING SEPTEMBER 11<sup>th</sup> and DECLARING BOISE COUNTY RECOGNIZE THE NATIONAL PATRIOT DAY of SEPTEMBER 11<sup>th</sup>**

**WHEREAS**, on September 11, 2001, the United States of America was suddenly and brutally attacked by foreign terrorists, and;

**WHEREAS**, these terrorists hijacked and destroyed four civilian aircraft, crashing two of them into the towers of the World Trade Center in New York City, a third into the Pentagon outside Washington, DC, and the fourth into a field in Somerset County, Pennsylvania, and;

**WHEREAS**, thousands of innocent Americans were killed and injured as a result of these attacks, including the passengers and crew of the four aircraft, workers in the World Trade Center and in the Pentagon, rescue workers, and bystanders, and;

**WHEREAS**, these cowardly acts were by far the deadliest terrorist attacks ever launched against the United States of America, and, by targeting symbols of American strength and success, clearly were intended to intimidate our nation and weaken its resolve, and;

**WHEREAS**, these horrific events have affected all Americans. It is important that we carry on with the regular activities of our lives. Terrorism cannot be allowed to break the spirit of the American people, and the best way to show these cowards that they have truly failed is for the people of the United States of America and their counties to stand tall and proud,



**THEREFORE BE IT RESOLVED**, that the governing board of Boise County, State of Idaho condemns the cowardly and deadly actions of these terrorists, and;
