A BOISE COUNTY RESOLUTION COMMEMORATING SEPTEMBER 11th and DECLARING BOISE COUNTY RECOGNIZE THE NATIONAL PATRIOT DAY of SEPTEMBER 11th

WHEREAS, these horrific events have affected all Americans. It is important that we carry on with the regular activities of our lives. Terrorism cannot be allowed to break the spirit of the American people, and the best way to show these cowards that they have truly failed is for the people of the United States of America and their counties to stand tall and proud,

THEREFORE BE IT RESOLVED, that the governing board of Boise County, State of Idaho condemns the cowardly and deadly actions of these terrorists, and;

BE IT FURTHER RESOLVED, that the governing board of Boise County, State of Idaho supports the President of the United States of America, as he works with his national security team to defend against additional attacks, and find the perpetrators to bring them to justice, and;
