

RESOLUTION #2005-29

WHEREAS, the Boise County Board of County Commissioners have the authority under Idaho Code §31-3904 to set the rates and fees for the services provided by East Boise County Ambulance District; and

WHEREAS, the Boise County Board of County Commissioners has determined that new rates and fees must be established to offset the increased cost of EBCA service;

NOW THEREFORE BE IT RESOLVED, that the Boise County Board of Commissioners rescinds Resolution #2002-12.

NOW FURTHER BE IT RESOLVED, that the Boise County Board of Commissioners set the East Boise County Ambulance rates and fees as follows:

\$12.00 per hour per EMT

(To be paid to the stand-by ambulance unit, upon receipt of payment.)

This Resolution shall be effective immediately upon adoption.
