A BOISE COUNTY RESOLUTION ADJUSTING THE FY 2004-2005 JUSTICE FUND BUDGET TO ALLOCATE CONTINGENCY FUNDS TO THE SHERIFF AND PRISONER BUDGET ACCOUNTS
