A RESOLUTION ESTABLISHING A SCHEDULE OF FEES FOR APPLICATIONS TO AMEND THE BOISE COUNTY COMPREHENSIVE PLAN

WHEREAS, Idaho Code §67-6509(d) provides for an application to amend the Boise County Comprehensive Plan; and

WHEREAS, any amendment to the Plan would require multiple Public Hearings pursuant to Idaho Code §67-6509; and

WHEREAS, any amendment to the Plan would require multiple public workshops; and

WHEREAS, significant staff time would be involved to facilitate and/or participate in the public workshops and Public Hearings.

NOW THEREFORE BE IT RESOLVED, that the Commissioners of Boise County hereby adapt a fee amount of \$1000.00 applicable to any application to amend any portion of the Boise County Comprehensive Plan. Such Fee schedule will become effective upon adoption of this Resolution.

Dear Commissioners:

I would like to offer a few options to the Resolution 2006-45 regarding the addition of a \$1,000 fee to those persons petitioning to amend the Comprehensive Plan. I agree that the process of revising a Comprehensive Plan can be extensive and costly and therefore understand the need to consider a fee. However, the fee appears to be prohibitive to the public input process. Instead, please consider the following options:

1. Make a commitment to revise the Comprehensive Plan every 3-5 years. At which time, the citizens of Boise County would have an opportunity to provide input to the revision, without having to pay a fee.
2. If someone petitions to revise the Plan, outside of the 3-5 year timeframe (for example one year after a revision), then the fee would apply, unless specific circumstances were to apply:
 - 2.a. specific circumstances could include (for example): the County's growth rate exceeds a predetermined percentage, a natural disaster occurs which was not described in the Plan and changes conditions.
3. In addition, I request that the fee only apply to a revision of the Plan and not to amendments, which can be as simple as an addition of a sentence.
