

**RESOLUTION # 2006-47  
A RESOLUTION ESTABLISHING  
AMOUNT OF FUNDING TO BE ASSIGNED TO  
TITLE II AND TITLE III PROJECTS**

**WHEREAS**, the counties having United States National Forests within their boundaries have been received Forest Reserve funds for roads and schools under the provisions of the Agricultural Reapportionment Act of 1908; and

**WHEREAS**, in the past decade federal land use policy has shifted away from multiple use approach to one in which decisions are made on a centralized basis with great attention given to single uses; and

**WHEREAS**, this approach has had a devastating negative impact on funding for schools and roads in forest counties; and

**WHEREAS**, the 106<sup>th</sup> Congress of the United States passed HR 2389 which seeks to maintain multiple use land management and reconnect local communities with management decisions made about their national forests; and

**WHEREAS**, Congress has made provision for local projects under Title II and III of HR 2389 whereby local Resource Advisory Committees will recommend projects which will enhance the safety and health of forests as well as enhance activities conducted within the National Forests within county boundaries.


**NOW THEREFORE BE IT RESOLVED** that Boise County intends to allocate the portion of funds which it receives for projects through the safety net payment in the following manner: Title II equal to 100% and Title III equal to 0%; and


**BE IT FURTHER RESOLVED** that a copy of this resolution be transmitted to the Governor of the State of Idaho by such date as may be necessary for it to reach the United States Secretary of Agriculture by September 30, 2006; and



**APPROVED AND ADOPTED** by the Boise County Board of Commissioners in open session on the 7<sup>th</sup> day of August 2006.



**Subject:** Craig-Wyden Payment Allocation

The National Forest Counties and Schools Coalition and others are working very hard to see that the Craig-Wyden Act is reauthorized. However, if it is not reauthorized, the current Act requires RACs to approve Title II project funding for next year's projects before September 30, 2006. **To help the RACs plan ahead, I am asking that you submit your resolutions before August 1, 2006.**

Pursuant to law, and for budgeting purposes, County Commissioners must submit to IAC, in the form of a resolution, the results of an election between the commissioners on the following decisions:

- Resolution:** What percentage (15-20%) of the secure payment will be set aside for Title II and/or Title III projects?
- Resolution:** Of that 15-20% specified in Resolution #2, what percentage will go to Title II and what percentage will go to Title III?

In order to allow the RACs the opportunity to determine the amount of money to be allocated to Title II projects before the September 30th deadline, please make these decisions in a timely manner and submit to IAC. The format used last year for the resolutions is appropriate for this year. NOTE: A county receiving less than \$100,000 need not complete any resolutions; however, can always elect to set aside money for Title II and/or Title III purposes.

I have included a chart outlining what each county received last year (the amount this year will adjusted to ½ the CPI) and what each county elected to send to Title II and Title III projects. Please remember that you can opt to change the percentage set aside for Title II and/or Title III Projects, as long as the total percentage set aside falls between 15-20% of the total amount.
