JOINT RESOLUTION WITH GEM COUNTY**



**WHEREAS**, the Gem County Board of Commissioners did approve and sign the Gem County Joint Resolution #2006-16 on November 14, 2006.



**APPROVED AND ADOPTED** by the Boise County Board of Commissioners in open session on the 20 day of November, 2006; with an effective date of passage.



BE IT RESOLVED this 14 day of November, 2006, between the County of Boise, located in Idaho City, Idaho (Boise County), and the County of Gem, located in Emmett, Idaho (Gem County);

WHEREAS, the respective Counties are political sub-divisions duly recognized, organized and existing under the general laws of the state of Idaho; and

WHEREAS, the Office of the Prosecuting Attorney is a statutorily required position that must be occupied in each County; and

WHEREAS, a vacancy exists in the Office of the Prosecuting Attorney in Boise County and there are (3) or fewer resident attorneys in Boise County who are willing and qualified to perform the functions of prosecuting attorney as set forth in chapter 26, title 31, Idaho Code; and

BE IT FURTHER RESOLVED that the Gem County Prosecutor Timothy L. Fleming is willing and able to serve Boise County and such representation would be mutually beneficial to the respective Counties; and

NOW, THEREFORE, BE IT RESOLVED that Timothy L. Fleming, Gem County Prosecuting Attorney, is hereby authorized and appointed to serve, act and perform the duties of prosecuting attorney as set forth in Idaho Code §31-2604, for the County of Boise, commencing on December 1, 2006 through January 15, 2009.
