RESOLUTION #2008-15 - Amended

A BOISE COUNTY EMERGENCY DECLARATION

WHEREAS, extreme winter snow has made most County roads impassable for City and County Emergency response vehicles, or reduced traffic flow to single lanes, and totally blocked many subdivision roads. These conditions have made it impossible for many residents to get medical attention, food or fuel. The current weather forecast is for additional heavy snowfall.

WHEREAS, it appears to the Boise County Board of Commissioners that:


1. An emergency is in existence in Boise County,
2. An emergency condition exists which local City, County and private resources are not adequate to fund.
3. The cities of Idaho City and Placerville have encountered the same conditions and have issued Disaster Declarations of their own,
4. The cities of Idaho City and Placerville have coordinated disaster relief with Boise County which is unable to meet their needs,


NOW, THEREFORE, BE IT RESOLVED be it resolved and declared by the Boise County Board of Commissioners at 3:05 P.M, Tuesday February 05, 2008 and amended on Thursday February 07, 2008 as follows.

1. An emergency exists within Boise County and all cities within, resulting from severe winter snowstorms.
2. Such emergency will require outside emergency assistance to supplement local efforts and to avert the impact of the emergency which has potential for loss of life and severe economic burden.

ADOPTED as a Resolution at the regular meeting of the Boise County Board of Commissioners on the 11th day of February 2008 upon a motion made by Commissioner Lawson, seconded by Commissioner Zimmerman.

Attachment to: Resolution 2008-15 (Amended) Disaster Declaration for extreme snowfall:

Specific requests are for either a heavy duty cat, truck/cat mounted snow blower or large front end loader to assist the Boise County Road and Bridge Department in moving the existing berms further off the county roads in the Clear Creek area, Centerville Road and Grimes Pass Road areas.

Current snowfall and mechanical breakdowns have prohibited Boise County Road and Bridge from moving heavy, deep snow far enough off the county roads to keep them wide enough for response vehicles, school busses. Boise County Road and Bridge is currently equipping one cat with snow wings to begin moving the berms off county roads. This cat should be ready for use on Feb 06, 2008 and begin work that day or the next.

Added 07 Feb 2008 (Amended)

Boise County: Plow multiple subdivision roads that are impassable. We have multiple residents living here who have known medical problems, need access for food and medical needs. There is currently no access for Law enforcement, Fire or ambulance in these areas.

Contractor is identified: 1 cat x \$100/hr x 8 hrs/day x 4 days = **\$3,200** plus staging costs of **\$640** = **\$3,840**
Additional Boise County request: \$3,840

Idaho City: Remove snow from the roofs of the Visitors Center and City water tower: **\$1,000**
IDOC - SICI work crew.

Remove snow from Main St, Montgomery St, Commercial St, East Hill Road, Courthouse area, Gold Rd, Cotton Wood St, Placer St and Elk Creek Road. Remove snow from the parking lots west of City Hall, the visitors Center and Basin School Dist. Snow will be removed to the football field parking lot and the Rodeo grounds parking lot.

Contractor is identified: 1 loader x \$100/hr x 8 hrs/day x 4 days = **\$3,200**, 1 Backhoe x \$85/hr x 8 hrs/day x 4 days = **\$2,720**, 3 dump trucks x \$80 / hr x 8 hrs/day x 4 days = **\$7,680**

Idaho City Total Request: \$14,600

Placerville:

Remove snow from 10 city streets that are totally blocked, 4 streets that are partially blocked.

Snow is to be removed to a location yet to be agreed upon by Boise County, BLM and USFS.

Contractor is identified: 2 loaders x \$85/hr x 8 hrs/day x 4 days = **\$5,440**, 2 dump trucks x \$70/hr x 8 hrs/day x 4 days = **\$4,480**. Staging charge, **\$960**

Placerville Total Request: \$10,880

Existing authorization (P-01-08-16 Amendment #1): **\$9,600.00**

Total additional request: **\$29,320.00**

Total Boise County Coordinated Request: **\$38,920.00**
