#### **RESOLUTION #2008-06**

### A BOISE COUNTY RESOLUTION SETTING THE SOLID WASTE FEES FOR TAX YEAR 2006

**WHEREAS,** Boise County Ordinance #82-2, an ordinance concerning a Solid Waste Disposal Fee for Boise County, Section II, states that the Boise County Board of Commissioners shall, by resolution, set the Solid Waste disposal fee amount for the ensuing year.

**NOW THEREFORE BE IT RESOLVED,** that the Solid Waste disposal fee for the 2007 Tax Year be set as follows:

See attached "Exhibit A;" and

Tax Exempt properties shall be classified for appropriate rates and billed separate and apart from other classifications.

**BE IT FURTHER RESOLVED,** that any person who has an approved circuit breaker application and has met the State criteria for net annual income shall be exempt from seventy-five per cent (75%) of the Solid Waste disposal fee, and

**BE IT FINALLY RESOLVED** that any exemptions previously reviewed by the Board and granted shall be continued unless circumstances warranting the original exemption have changed.

This Resolution shall be effective upon date of adoption.
