## RESOLUTION #2023-07 A BOISE COUNTY RESOLUTION ADJUSTING THE BOISE COUNTY REVALUATION FUND FY2023 BUDGET

**WHEREAS**, the FY 2023 budget, for the Boise County Revaluation Fund, was adopted by the Board of County Commissioners on August 30<sup>th</sup>, 2022 via Boise County Resolution 2022-29; and

**WHEREAS**, Idaho Code Section 31-1608 provides for the Board of County Commissioners to adjust the budget, as adopted, to meet mandatory expenditures required by law; and

**WHEREAS**, the Boise County Revaluation Fund will incur higher than anticipated staff training costs, as training that was originally budgeted and scheduled for FY2022, did not occur, due to the need to rebuild the property database subsequent to the May of 2022 Boise County server failure, and;

**WHEREAS**, the Boise County Revaluation Fund will incur supplies expense, in the process of performing the duties required in revaluing Boise County property, in accordance with Idaho Code, and;

**WHEREAS**, a Supplies expense budget was inadvertently omitted in the original Boise County Revaluation Fund appropriated budget for FY2023, and;

**WHEREAS**, Idaho Code Section 31-1608 allows the county commissioners, by the unanimous vote of the commissioners, to make the expenditures necessary to provide for and meet mandatory expenditures, by the adoption of a resolution stating the facts constituting the emergency, and;

**WHEREAS**, Idaho Code Section 31-1608 provides for all emergency expenditures to be paid from any moneys on hand in the county treasury in the fund properly chargeable with such expenditures.

**NOW THEREFORE BE IT RESOLVED**, that the FY 2023 budget for the Boise County Revaluation Fund, be adjusted as follows:
