## RESOLUTION

WHEREAS, Idaho Code 31-1604<sup>states that</sup> the Boise County Board of Commissioners are empowered to consider budgets proposed by the county budget office and approve tentative amounts to be allowed and ~~appropriated~~<sup>appropriated</sup> for the ensuing fiscal year, and

WHEREAS, the proposed budgets must be based on the analysis of anticipated revenues and fund balances, and

WHEREAS, the Boise County Board of Commissioners in their analysis have determined that anticipated revenue for the fiscal year 1984-1985 beginning October 1, 1984 thru September 30, 1985 is not adequate to fund these budgets at the current level of funding, and

WHEREAS, an Override Election held on May 25, 1984 for additional revenue was defeated by the voters of Boise County.

NOW THERE FOR BE IT RESOLVED, that effective October 1, 1984, the following elected official's will be reduced 20% from the Fiscal year 1983-84 salary: Commissioners, Auditor, Treasurer, Assessor and that the Sheriff, Prosecuting Attorney and Coroner's salaries be reduced 10% from the fiscal year 83-84 salary, and

FURTHER, that employees in the Auditor, Treasurer, Assessor, and Prosecuting Attorney's office be reduced 20% from the fiscal year 1983-84<sup>Data Processing</sup> and that employees in the Sheriff's office be reduced 10% from the fiscal year 83-84 salaries, and

FURTHER, that <sup>salaries of</sup> employees of the Road Department and Solid Waste Department be reduced 10% of the fiscal year 1983-1984 salaries, and

FURTHER, that any other reductions or adjustments in appropriations be made as deemed necessary by the Board to obtain a balanced budget, and

FURTHER, that the offices of the Treasurer, Auditor, Assessor and Prosecuting Attorney be closed on Friday of each week. Employees will work four (4) seven hour days from Monday thru Thursday from 9 a.m. until 12 noon and 1:00 p.m. until 5:00 p.m., that the offices of the Treasurer, Auditor, Assessor, and Prosecuting Attorney will be open to the public from 1:00 to 5:00 p.m. Monday thru Thursday only, and <sup>Data Processing</sup>

FURTHER, that the hours of the Sheriff's and District Court will be adjusted as deemed necessary by the elected officials responsible for those offices; and

FURTHER, that the satellite station of the Assessor's office located in Garden Valley, Idaho be closed effective October 1, 1984; and

FURTHER, that the Courthouse annex in Horseshoe Bend be open to the public from 1:00 to 5:00p.m. Monday <sup>and</sup> ~~thru~~ Thursday only, and

FURTHER, that the effective date of this resolution shall be October 1, 1984.
