RESOLUTION # ~~86~~ 4-86

WHEREAS, Boise County Ordinance #82-2, an ordinance concerning a Solid Waste Disposal fee for Boise County, Idaho, Section II states that the Boise County Board of Commissionrs shall, by resolution, set the Solid Waste Disposal Fee amount for the ensuing year.

NOW THEREFORE BE IT RESOLVED, that the fee for Solid Waste for Fiscal Year 1986-87 be set at \$18.00 for individual households and \$54.00 for commercial establishments; and

FURTHER, that any person who has an approved circuit breaker application and has a net annual income of \$8,000. or less shall be exempt from any Solid Waste Fee; and

FURTHER, that any exemptions previously reviewed by the Board and granted be continued unless circumstances warranting the original exemption have changed.

That this exemption shall be effective October 1, 1986.
