

RESOLUTION NO. 88-7

AMENDED RESOLUTION FOR THE FORMATION OF
EAST BOISE COUNTY AMBULANCE DISTRICT

WHEREAS, at a regular meeting of the Boise County Board of Commissioners held on July 27, 1987 a petition for the formation of a taxing district to be called the East Boise County Ambulance District was presented, to wit:

We, the undersigned, being resident real property holders within the proposed district, Boise County, hereby petition the Boise County Board of Commissioners in accordance with Idaho Code 31-3908 to establish and maintain an Ambulance Taxing District within the county. Boundaries of the East Boise County Ambulance District will be as follows:

EAST BOISE COUNTY AMBULANCE DISTRICT

Beginning at the Northwest corner of Section 6, T. 10 N., R. 7 E., B.M. Thence South 6 miles more or less along the township line to the Southwest corner of Section 31, T 10 N., R. 7 E., B.M. Thence West along the South line of Section 36, T. 10 N., R. 6 E., B.M. to the Northwest corner of Section 6, T. 9 N., R. 7 E., B.M. Thence South 6 miles more or less along the township line to the Southwest corner of Section 31, T. 9 N., R. 7 E., B.M. Thence West 6 miles more or less to the Northwest corner of Section 6, T. 8 N., R. 6 E., B.M. Thence South along the township line 2 miles more or less to the Northeast corner of Section 13, T. 8 N., R. 5 E., B.M. Thence West along the North boundaries of Sections 13, 14, 15, 16, and 17 in T. 8 N., R. 5 E., B.M., 5 miles more or less to the Northwest corner of Section 17, T. 8 N., R. 5 E., B.M. Thence South along the West boundaries of Sections 17, 20, and 29 in T. 8 N., R. 5 E., B.M., 3 miles more or less to the Southwest corner of Section 29, T. 8 N., R. 5 E., B.M. Thence West along the North boundaries of Section 31, T. 8 N., R. 5 E., B.M., and Sections 35 and 36, T. 8 N., R. 4 E., B.M., 3 miles more or less to the Northwest corner of said Section 35. Thence South along the West boundary of Section 35, 1 mile more or less to the Southwest corner of the Section. Thence West along the North boundaries of Sections 3, 4, 5 and 6 in T. 7 N., R. 4 E., B.M., 4 miles more or less to the Northwest corner of Section 6, T. 7 N., R. 4 E., B.M. Thence South along the Range line 19 miles more or less to the Northeast corner of Section 12, T. 4 N., R. 3 E., B.M. Thence West along the North lines of Sections 7, 8, 9, 10, 11 and 12 in T. 4 N., R. 3 E., B.M. to its intersection with the Ada County line. Thence in a Southeasterly direction along the Boise/Ada County line to its intersection with the Elmore County line. Thence in a Northeasterly direction along the Boise/Elmore County line to its intersection with the Custer County line. Thence along the Boise/Custer County line to its intersection with the Valley County line. Thence along the Boise/Valley County line to the point of beginning.

Said petition contained eighty-four signatures which were verified electors or resident real property holder. Sixty-one signees were both electors and resident real property holders, forty-eight signees were not verified by the Boise County Clerk, and

WHEREAS, upon receipt of the certified petition the Board of County Commissioner caused the text of the petition to be published for three consecutive weeks in the Idaho World and included a notice of the time of the meeting when the petition would be considered and stated that all persons interested may appear and be heard, and

WHEREAS, said meeting was held at which twenty-three persons were present and nineteen offered testimony and twenty-two letters were offered in written testimony, and

WHEREAS, Idaho Code requires that a decision be rendered by the Board within thirty days of the public meeting,

NOW THEREFORE BE IT RESOLVED that the East Boise County Ambulance District be formed with the boundaries laid out in the resolution.

THIS RESOLUTION shall be in full force and effect upon its passage and publication as required by law and to the maximum extent permitted by law retroactive to the effective date of passage of Resolution 87-5 passed by the Boise County Board of Commissioners on November 2, 1987, creating the East Boise County Ambulance District.
