RESOLUTION NO. 13-93

A RESOLUTION ESTABLISHING A SCHEDULE OF FEES FOR APPLICANTS IN ACCORDANCE WITH CHAPTER 4, SECTION 2, SUBSECTION b-2; CHAPTER 5, SECTION 5, SUBSECTION a-4; CHAPTER 5, SECTION 6, SUBSECTION b; OF ORDINANCE NO. 93-1 OF BOISE COUNTY, IDAHO, (SUBDIVISION) ORDINANCE AS AMENDED ON SEPTEMBER 20, 1993.

WHEREAS, Chapter 4, Section 2, Subsection b-2 provides for the establishment of a schedule of fees for the processing of segregation plat applications; Chapter 5, Section 5, Subsection a-4 provides for the establishment of a schedule of fees for the processing of full subdivision preliminary plat applications; and Chapter 5, Section 6, Subsection b provides for the establishment of a schedule of fees for the processing of final subdivision plat applications, and

WHEREAS, such fees should bear a reasonable relationship to the costs incurred by Boise County in the processing of the subdivision application,

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BOISE COUNTY, THAT THE FOLLOWING SCHEDULE OF FEES FOR THE PROCESSING OF ALL SUBDIVISION APPLICATIONS BE ADOPTED IN ACCORDANCE WITH CHAPTER 4, SECTION 2, SUBSECTION b-2; CHAPTER 5, SECTION 5, SUBSECTION a-4; AND, CHAPTER 5, SECTION 6, SUBSECTION b OF ORDINANCE NO. 93-1 OF BOISE COUNTY:

1. Segregation Plat Applications: \$300.00 per application plus \$50.00 per lot.
2. Full Subdivision Preliminary Plat Applications: \$300.00 plus \$5.00 per acre, up to 100 acres; \$1.00 per acre over 100 acres.
3. Final Subdivision Plat Applications: \$300.00 plus \$20.00 per lot for each lot or living unit included in the final plat application.
4. Street and Road Plans Review and Site Inspection: \$50.00 plus \$0.10 per centerline foot.

BE IT FURTHER RESOLVED that in addition to the above fees each applicant shall pay any direct professional fees incurred by the Board in the processing, investigation and review of each subdivision application, including but not limited to fees of the designated county engineer, any licensed surveyor and fees of any other professional whose contract services are required by the Board to render a decision on any subdivision application.

BE IT FURTHER RESOLVED that this schedule of fees shall be effective upon passage of this resolution.
