

## BOISE COUNTY BOARD OF COMMISSIONERS THURSDAY, APRIL 20<sup>th</sup>, 2023 IDAHO CITY COMMISSIONER ROOM **OFFICIAL SPECIAL MEETING MINUTES**

**IN ATTENDANCE:** Chairman Twilegar, Commissioner Tucker, Commissioner Lindstrom, Deputy Prosecutor Gross, Clerk Prisco, Assessor Juszczak, and Deputy Clerk Coffelt.

Chairman Twilegar called the meeting to order.

**RESOLUTION:** Resolution 2023-11; to adopt a no build option for the Lava Ridge Wind Turbine project was presented to the Board, reviewed and discussion ensued. Chairman Twilegar MOTIONED to adopt Resolution 2023-11; a Boise County resolution to support neighboring Idaho Counties, (Twin Falls, Jerome, Gooding, Lincoln, Minidoka, Cassia, and Washington) expressing concern over the proposed Lava Ridge Wind Turbine Project and supporting "Alternative A – No-Build Option" for the Lava Ridge Project. Commissioner Tucker SECONDED; All Ayes.

**PA OFFICE SUMMER INTERN STIPEND DISCUSSION:** Discussion ensued among Deputy Prosecuting Attorney Gross, Clerk Prisco and the Board concerning paying a stipend to a summer intern for the Prosecuting Attorney's Office.

**SERVER ROOM POWER SOLUTION:** IT Director McCracken, Assessor Juszczak and Clerk Prisco spoke to the Board concerning the purchase of equipment for the server room, documentation was presented to the Board, and discussion ensued. Chairman Twilegar MOTIONED to purchase some power conditioning equipment-the Vertiv Liebert GXT5 as per outlined in the bid up to the amount of \$25,527.26. Commissioner Lindstrom SECONDED; All Ayes.
