## RESOLUTION #2024-12

### A BOISE COUNTY RESOLUTION ADOPTING THE BOISE COUNTY VOLUNTEER POLICY

**WHEREAS**, the Boise County Board of Commissioners has approved the Boise County Volunteer Personnel Policy, known as Resolution 2024-12; and

**WHEREAS**, a diligent review and discussion of the policy has been held by the Boise County Board of Commissioners; and

**WHEREAS**, agreement has been reached, by the Board, that the additional Boise County Volunteer Personnel Policy, known as Resolution 2024-12, is necessary to reduce liability and to better safeguard Boise County community members rights and Boise County's actions; and

**WHEREAS**, agreement has been reached, by the Board, that pursuant to this Boise County Volunteer Personnel Policy, any and all volunteers for Boise County service, including but not limited to: Boise County Sheriff's Office Reserve Deputies and Boise County Planning and Zoning Commissioners, shall abide by the following six (6) policies: (1) Discrimination Complaint Procedure Policy, known as Resolution 2013-3; (2) Non-Discrimination Policy, known as Resolution 2013-38; (3) Travel Policy, known as Resolution 2017-24; (4) Information Systems Policy, known as Resolution 2018-35; (5) Password Policy, known as Resolution 2019-13; (6) Social Media Policy, known as resolution 2021-26; and (7) Sections I through V, subsections B., C., D., and E. of Section VI, and Appendix "C" of the Personnel Policy, known as Resolution 2024-08; and

**NOW THEREFORE BE IT RESOLVED**, that the Boise County Board of Commissioners does hereby adopt the Boise County Volunteer Personnel Policy, known as Resolution 2024-12, which requires any and all volunteers for Boise County service, including but not limited to: Boise County Sheriff's Office Reserve Deputies and Planning and Zoning Commissioners, to abide by the following six (6) policies: (1) Discrimination Complaint Procedure Policy, known as Resolution 2013-3; (2) Non-Discrimination Policy, known as Resolution 2013-38; (3) Travel Policy, known as Resolution 2017-24; (4) Information Systems Policy, known as Resolution 2018-35; (5) Password Policy, known as Resolution 2019-13; (6) Social Media Policy, known as resolution 2021-26; and (7) Sections I through V, subsections B., C., D., and E. of Section VI, and Appendix "C" of the Personnel Policy, known as Resolution 2024-08; and

**IT IS FURTHER RESOLVED** that this Boise County Volunteer Personnel Policy, known as Resolution 2024-12, shall be applicable to all subsequent and replacement policies to the six (6) Policies (and applicable sections) listed herein, without further action of the Boise County Board of Commissioners; and

**IT IS FURTHER RESOLVED** that Resolution 2024-12, known as the Boise County Volunteer Personnel Policy, be effective as of February 13<sup>th</sup>, 2024.
