In 2023 my husband, parents and I started making plans of turning this dream into a reality. Our goal is to establish a facility that not only serves as a practical storage solution but also enhances the outdoor experience for families and adventurers alike. Leveraging our family's expertise in concrete and excavation, along with the support of friends in related industries, we are poised to transform this once bare land into a functional and accessible RV storage space.

Our plan is grounded in simplicity and practicality. We envision a well-organized gravel lot, marked with clear space dividers, and secured with a perimeter fence and an automated gate for security. This foundational setup aims to provide a hassle-free storage solution, free from the complexities of navigating RVs and boats through the challenging hill that separates the northern mountains from the valley.

Our facility's strategic location, easily accessible off the main Highway 55 and tucked away on Hanson Road, offers a dual advantage. It provides convenient access for our customers while minimizing traffic impact. This location is not just a storage point but a gateway to the mountains, encouraging more visitors to explore the natural beauty of our region, thereby contributing to local business growth.

In essence, Around the Bend RV Storage is more than just a business venture; it's a family legacy in the making. It's a testament to our commitment to the community, our love for the great outdoors, and our dedication to providing a service that enriches the lives of those around us.

Development for Around the Bend RV Storage

Central to this is the development of a level gravel lot, meticulously designed for ease of access and security. The entire lot will be covered with gravel, with clear markings on the gravel to designate individual storage spaces, ensuring organized and efficient use of the area.

A key feature of our facility's design is a 16-foot automated gate at the entrance. This gate will provide seamless and secure access for our customers, enhancing the safety and integrity of the stored vehicles. The automated gate is designed to accommodate a wide range of vehicle sizes, ensuring easy entry and exit for all types of RVs and trailers.

Permanent lighting installations will not be present, with the only lighting coming from vehicle lights to minimize environmental impact. A sturdy security fence will encircle the lot, adding an additional layer of security and privacy.

The storage lot will feature a total of 114 spaces, thoughtfully segmented into two categories to accommodate diverse vehicle sizes. Specifically, 88 spots will measure 40'x12', suitable for standard-sized RVs, while an additional 26 spots, ranging from 44'x12' to 65'x12', will cater to larger vehicles and trailers. The facility's layout includes a 30-foot-wide driveway, designed for one-way traffic to ensure smooth and efficient movement within the premises, enhancing the overall customer experience.

Noxious Weed Control Compliance:

In our commitment to environmental stewardship and community responsibility, Around the Bend RV Storage will adhere strictly to all local and state regulations regarding noxious weed control. Recognizing the importance of maintaining the natural beauty and ecological balance of Boise County, we will implement a comprehensive weed management plan.
