**OFFICIAL MEETING MINUTES**

**IN ATTENDANCE:** Chairman Twilegar, Commissioner Tucker, Prosecuting Attorney Sosa, Civil Deputy Prosecuting Attorney Gross, Clerk Prisco, Deputy Clerk Coffelt, Sheriff Turner, Assessor Juszcak, Road & Bridge Superintendent Dill, Solid Waste/Noxious Weeds Superintendent Rekow, Community Justice Administrator Leader.

Chairman Twilegar called the meeting to order and the pledge of allegiance was recited.

Chairman Twilegar MOTIONED to approve the job description for the Administrative Assistant/Community Service Coordinator with the additions. Commissioner Tucker SECONDED; All Ayes.

Chairman Twilegar MOTIONED to approve the changes on the job description for Grounds Maintenance position. Commissioner Tucker SECONDED; All Ayes.

Clerk Prisco updated the Board concerning the Idaho City and Garden Valley snow grooming program finances.

Ms. Prisco also updated the Board on the progress that has been taking place with the compensation project which is being prepared to share with the Board during the fiscal year 2024 budget discussions.

Sheriff Turner updated the Board on the happenings at the Robie Creek Park and how he would like to proceed concerning the Army Corps of Engineers

Road & Bridge Superintendent Dill updated the Board on the dust abatement that has been taking place in Boise County.
