

## BOISE COUNTY BOARD OF COMMISSIONERS MONDAY, JULY 7<sup>th</sup>, 2025 IDAHO CITY COMMISSIONER ROOM **OFFICIAL MEETING MINUTES**

**IN ATTENDANCE:** Chairman Tucker, Commissioner Lindstrom, Prosecuting Attorney Sosa, Clerk Prisco, Deputy Clerk Mayo, Assessor Juszczak, Chief Deputy Assessor Kline, Deputy Assessor Randall, Deputy Assessor Freeman-Ritter, Deputy Assessor Vanderburgh, and Deputy Assessor Schuppan.

Chairman Tucker called the meeting to order and the pledge of allegiance was recited.

The Assessor's Office presented their case for the assessment to the Board, review and discussion ensued. The Board deliberated on this case. Chairman Tucker tabled the decision until later in the day for going over the allotted time. Coming back to discuss the appeal, discussion ensued. Chairman Tucker MOTIONED to sustain the Assessor's value of RP09N04E108570 and RP09N04E108580 and for out building of RP09N04E108580. Commissioner Lindstrom SECONDED; All Ayes. Commissioner Callahan abstained for not having all the evidence in front of him

Prosecuting Attorney Sosa was asked to explain the differences between Idaho Codes: ID Code 63-501(A) Sub Sec 1-Taxpayer's Right to Appeal and State Tax Commission Code 35.01.03.219 Actual partition of parcels rather than the assessment of property. They are two (2) separate issues. Prosecutor Sosa stated that Mr. Chitwood may come to a scheduled Boise County Commissioner meeting and talk to that board of his concern on that matter. The Board deliberated on this case. Chairman Tucker tabled for more discussion later in the day. Coming back from lunch the Board deliberated more on this matter. Chairman Tucker MOTIONED to sustain the Assessor's value on RP04N05E265600. Commissioner Lindstrom SECONDED; All Ayes.
