

## BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, OCTOBER 21st, 2025 IDAHO CITY COMMISSIONER ROOM OFFICIAL MEETING MINUTES

Chairman Tucker called the meeting to order and the pledge of allegiance was recited.

Commissioner Lindstrom MOTIONED to approve this Demand Warrant for FY25 to Averhealth in the amount of \$25.00. Commissioner Callahan SECONDED; All Ayes. Commissioner Lindstrom MOTIONED to approve this Demand Warrant for FY25 to Idaho Power in the amount of \$124.41. Commissioner Callahan SECONDED; All Ayes. Two (2) Demand Warrants from the Clerk's Office for FY25 and FY26 were in front of the Board, discussion ensued. Commissioner Lindstrom MOTIONED to approve this Demand Warrant for FY25 to IAC-Unemployment 2<sup>nd</sup> quarter wage fees in the amount of \$1,663.95. Commissioner Callahan SECONDED; All Ayes. Commissioner Lindstrom MOTIONED to approve this Demand Warrant for FY26 to IAC-Unemployment 3<sup>rd</sup> quarter wage fees in the amount of \$2,084.51. Commissioner Callahan SECONDED; All Ayes. A Demand Warrant for R&B IC Shop was in front of the Board. Commissioner Lindstrom MOTIONED to approve this demand warrant to Canon Financial Services for September FY25 in the mount of \$28.85. Commissioner Callahan SECONDED; All Ayes. A demand warrant for the Coroner's Office was in front of the Board. Commissioner Lindstrom MOTIONED to approve this demand warrant for FY25 to Intermountain Communications in the amount of \$45.00. Commissioner Callahan SECONDED; All Ayes.

**EBCAD:** Chairman Tucker recessed as the Boise County Board of Commissioners and reconvened as the East Boise County Ambulance District, Governing Board. A Demand Warrant for FY25 came in front of the Board, discussion ensued. Commissioner Lindstrom MOTIONED to approve this Demand Warrant for

FY25 to Idaho Power for FY25 for Idaho City Ambulance Station Electricity in the amount of \$149.53. Commissioner Callahan SECONDED; All Ayes. Chairman Tucker adjourned as the EBCAD Governing Board and reconvened as the Board of County Commissioners.

Roll call vote: Chairman Tucker – Aye; Commissioner Lindstrom – Aye; Commissioner Callahan – Aye. Motion passed unanimously. Prosecuting Attorney Sosa and Assessor Juszczak were present in executive session. Chairman Tucker brought the meeting out of executive session per I.C. 74-206(1)(f), pending Litigation. Commissioner Lindstrom MOTIONED to approve to pay up to \$10,000.00 for surveying on and around County Property. Commissioner Callahan SECONDED; All Ayes.
