

BOISE COUNTY BOARD OF COMMISSIONERS TUESDAY, DECEMBER 9th, 2025 IDAHO CITY COMMISSIONER ROOM

OFFICIAL MEETING MINUTES

Commissioner Lindstrom MOTIONED to approve Resolution 2026-05, a Boise County Resolution increasing the Boise County Justice Fund, Sheriff's Department, FY2026 Budget (for a restricted donation to purchase search and rescue snow bikes). Commissioner Callahan SECONDED; All Ayes. Commissioner Lindstrom MOTIONED to approve Resolution 2026-06, a Boise County Resolution increasing the Boise County General Fund, Information Technology Department, FY2026 Budget (for the unanticipated purchase of grant related software). Commissioner Callahan SECONDED; All Ayes.
