RESOLUTION #2026-13

A BOISE COUNTY RESOLUTION INCREASING THE BOISE COUNTY JUSTICE FUND, PROSECUTING ATTORNEY DEPARTMENT, FY 2026 BUDGET

WHEREAS, the FY 2026 budget, for the Boise County Justice Fund, Prosecuting Attorney budget, was adopted by the Board of County Commissioners on August 26th, 2025, via Resolution 2025-44; and

WHEREAS, Idaho Code Section 63-805(2) allows the Board of County Commissioners to make a "general reserve appropriation", not to exceed five percent (5%) of the county justice fund budget as finally adopted; and

WHEREAS, Idaho Code 31-1606 establishes the estimate of expenditures, using the three general classifications, as finally fixed and adopted as the county budget, by the Board of County Commissioners, as constituting the appropriations for the county for the ensuing year; and

WHEREAS, Idaho Code Section 31-1606 establishes that no salary may be increased during the ensuing year after the final budget is adopted, without resolution of the Board of County Commissioners; and

WHEREAS, the Board of County Commissioners has agreed that an increase in compensation for the Deputy Prosecuting Attorney positions (two positions) is needed; and

WHEREAS, the Board finds it necessary to increase the Justice Fund, Prosecuting Attorney budget, for salary and benefits associated with the increased compensation and benefits, for the two Deputy Prosecutor positions; and

WHEREAS, the annual budget procedure has been complied with in making the said adjustment and the budget amendment shall not result in increased property taxes.

NOW THEREFORE BE IT RESOLVED, that the FY 2026 budget, for the Boise County Justice Fund, Prosecuting Attorney Department, be amended as follows:
